Solicitors Qualifying Examination (SQE)

In 2021, the Solicitor's Qualifying Exam will bring an entirely new way of testing your legal knowledge and lawyering skills, consisting of two stages. SQE1 is a computer-based exam which will test your functioning legal knowledge by way of multiple-choice questions, mirroring the US bar exams. After passing SQE1, you will be eligible to apply and sit for SQE2, consisting of practical legal skills assessments such as client interviewing, advocacy and more.

Why take the SQE?

- Flexibility and affordability – spread both the preparation course and exam fees over a longer period to adapt the pace to fit your schedule and budget
